Thence South 85° 55' 24" East along the Southerly line of said Newbury Township a distance of 1423.78 feet to a 5/8 inch iron pin found at the Southwesterly corner of land conveyed to Lloyd Frohring by deed recorded in Volume 218, Page 128 of Geauga County Deed Records;

COURSE II

Thence South 85° 41' 44" East continuing along said Southerly line of Newbury Township also being the Southerly line of land so conveyed to Lloyd Frohring a distance of 387.92 feet a 5/8 inch iron pin set at the Northwesterly corner of land conveyed to William AKA William C.
