





REVISED LEGAL DESCRIPTION OF A 2.2181 ACRE PARCEL AUBURN TOWNSHIP

Situated in the Township of Auburn, County of Geauga and State of Ohio and known as being a part of Original Lot No. 16, Section 5 in Tract No. 1 in said Township and is further known as a part of a parcel of land conveyed to Robert A. and Agnes C. Cavanagh by deed recorded in Volume 992, Page 962 of Geauga County Official Records and is further bounded and described as follows:

Beginning at a 1 inch iron pipe in the centerline of Stafford Road, (60 feet wide) said point being North 89°10'00" West, 50.92 feet from the Southwest corner of land conveyed to Murry D. and Pauline N. Bay by deed recorded in Volume 875, Page 207 of Geauga County Official Records; Thence South 89°10'00" East, along said centerline and Southerly line of said Bay, 368.89 feet to the Southeast corner thereof and the Principal Place of Beginning of the premises herein intended to be described;

Thence North 2°28'00" West, along the Easterly line of said Bay, passing through a 1¼" inch iron pipe at 30.05 feet on the Northerly sideline of said Stafford Road, 292.39 feet to the Northeast corner of said Bay, and the Southerly line of land conveyed to Victoria Development Company by deed recorded in Volume 979, Page 490 of Geauga County Official Records, said point being 0.11 feet North and 0.37 feet East of a bent 1 inch iron pipe;

COURSE II

Thence North 88°23'30" East, along the Southerly line of said Victoria Development Company, 195.46 feet to a 5/8 inch iron pin found at the Southeast corner thereof;

COURSE III

Thence South 89°10'00" East, 137.43 feet to a 5/8 inch iron pin set;

COURSE IV

Thence South 00°50'00" West, 300.23 feet (passing through a 5/8 inch iron pin set at the Northerly sideline of said Stafford Road, 270.23 feet) to the centerline of said Stafford Road;

COURSE V

Thence North 89°10'00" West, along the centerline of said Stafford Road, 315.88 feet to the Southeast corner of said Bay and the Principal Place of Beginning and containing 2.2181 acres (2.000 exclusive of right-of-way) of land as calculated from a survey performed in October of 1996, by Richard A. Thompson, Jr., P.S. No. 7388 of LDC, Inc., be the same, more or less, but subject to all legal highways and easements of record. Bearings used in this description are to the centerline of Stafford Road as per deed recorded in Volume 875, Page 207 of Geauga County Official Records.
